Overview

The **Pre-ID** data collection is designed to help school systems report accurate demographic and program data on selected state-mandated assessments. Data collected through the Pre-ID data collection is used to generate labels that are included among the test materials sent from the test vendor to the school systems. Use of Pre-ID labels alleviates the need for students and/or teachers to bubble demographic and program data on answer documents. As a result, school systems are able to accurately match assessment records to student record data reported at the end of the school year.

Pre-ID is setup to allow access to the following district level users: FTE Coordinator, Student Record Coordinator, and the Assessment Coordinator. These individuals are able to upload files, delete data, and access reports.

There are two data collection cycles for Pre-ID labels.

- 1. **Cycle 2**: In September, data is collected to generate labels for the Georgia Milestones End of Course for students in grades 7-12.
- 2. **Cycle 3:** In January, data is collected to generate labels for the Georgia Milestones End of Course (EOC) for students in grades 7-12, and the Georgia Milestones End of Grade (EOG) for students in grades 3-8.

General Information

Pre-ID data is reported for active students. Withdrawn students should not be extracted and reported in Pre-ID as they will not require labels for the designated test types.

The Test IDs reported for a given cycle must be valid for that cycle. See the Pre-ID Transmission Dates to determine which Test IDs are valid for each cycle.

A warning will be generated for a given school and test ID, if either of the following conditions is true:

- No SRC codes are reported; or
- More than 25% of the students report a SRC code.

Data Elements

Listed below are the data elements collected in each Pre-ID data collection. Although the same type of information is reported in each cycle, it is important to note that each record must reference the test ID that is valid for the cycle and the student's grade level. COURSE NUMBER

COURSE NUMBER is the 9-digit number designating an official course as specified in SBOE Rule 160-4-2-.03 or 160-4-2-.20. Course numbers are only valid in Pre-ID when reporting data for EOC labels (TEST ID is 12).

COURSE SECTION NUMBER

The **COURSE SECTION NUMBER** identifies a specific group of students taking a course number. The course section may contain alpha and/or numeric values. Numeric values may go up to 999. Special characters are not valid. The course section number is only allowed when the TEST ID is 12.

DATE OF BIRTH

DATE OF BIRTH is the date of the student's birth. It must be in the format **YYYYMMDD**. The first two positions in the year cannot be less than '19'.

ENGLISH LEARNER (EL)

ENGLISH LEARNER (EL) indicates whether the student has been identified as having limited proficiency in English (**ENGLISH LEARNER (EL)='Y'**). Once a student has tested out of the **ENGLISH LEARNER** program, the student is monitored for 2 years to ensure that the student no longer requires **ENGLISH LEARNER** services. The first full year that a student is out of the **ENGLISH LEARNER** program, the student is marked **ENGLISH LEARNER (EL)** ='1'. The second full year that a student is out of the **ENGLISH LEARNER** program, the student is marked **ENGLISH LEARNER (EL)**='2'. After two years of monitoring, the student should be reported with **ENGLISH LEARNER (EL)** = '3' (No longer **EL**; no longer monitored; tested out of **ENGLISH LEARNER (EL)** 3 years ago); the next year, **ENGLISH LEARNER (EL)** = '4' (No longer **EL**; no longer monitored; tested out of **EL** 4 years ago). After 4 full years out of the **ENGLISH LEARNER** program, the student would be reported with **ENGLISH LEARNER (EL)** = 'F' (Former EL Student) for all subsequent years.

If the student was incorrectly report as an **ENGLISH LEARNER** in the past and was never qualified as an **ENGLISH LEARNER**, report the student with **ENGLISH LEARNER (EL) =** 'l'.

Must equal one of the following codes:

EOG EOC ELA

Indicates that a student in GRADE LEVEL 6–8, is not taking the grade appropriate EOG language arts

assessment because the student is in a higher level language arts course that has an EOC assessment. **EOG EOC MATH**

Indicates that a student in GRADE LEVEL 6– 8, is not taking the grade appropriate EOG mathematics assessment because the student is in a higher level mathematics course that has an EOC assessment.

EOG EOC SCIENCE

Indicates that a student in GRADE LEVEL 6 - 8, is not taking the grade appropriate EOG science assessment because the student is in a higher level science course that has an EOC assessment.

ETHNIC HISPANIC

ETHNIC HISPANIC is a code that indicates the ethnicity of a student. Valid codes are:

FIRST NAME

FIRST NAME identifies the student's FIRST NAME as it appears in the school records. Numbers are not valid characters in the name.

GENDER

GENDER is a code (*M* Male or *F* Female) which identifies the student's gender.

GRADE LEVEL

GRADE LEVEL is a code that indicates the student's current grade placement. Valid codes are:

<u>GTID</u>

GTID is the unique testing identifier assigned to each student in grades Pre-K-12. This is a 10-character alphanumeric field that must contain numbers only. It is set up as alphanumeric for formatting purposes, but letters and special characters are not allowed in this field.

LAST NAME

LAST NAME is the student's LAST NAME as it appears in the school records. Numbers are not valid characters in the name.

MIDDLE INITIALS

MIDDLE INITIAL is a code which identifies the student's middle initial. Middle Initial must be either alpha characters (A-Z) or blank.

MIGRANT

MIGRANT CODE indicates whether the student has been identified as a migrant student.

- 'Y' Yes, student is in the Migrant Education Program.
- 'N' No, student is not in the Migrant Education Program.

'C' Continuation of Services

Definition of a Migrant Student:

- Is younger than 22.
- Has not graduated from high school or does not hold a high school equivalency certificate.
- Is a migrant agricultural worker or has a parent, spouse, or guardian who is a migrant agricultural worker.
- Has moved from one school district to another within the preceding 36 months in order to obtain (or seek) temporary or seasonal employment in qualifying agricultural work.

ONLINE INDICATOR

The Online Indicator (Y/N) tells whether or not the test will be taken online or on paper. The online indicator is only valid for Georgia Milestones EOC or Georgia Milestones EOG.

PURPOSE FOR TAKING TEST

To be used to determine which students should be included in the Assessment Summary Reports for Georgia Milestones.

1	Completion of Course	Student is completing a current enrollment associated with an EOC.
2	Makeup from previous administration	Student is completing ("making-up") their EOC requirement that stems from a previous EOC administration window.
<u>3</u>	Retest	Student is retesting due to a Grade Conversion Score below 70 received during a previous administration.
<u>4</u>	Test-Out	Student is attempting to demonstrate subject area competency for an EOC course, that they have not yet taken.
5	Validation of Credit	Student is enrolling from a non-accredited home study program, private school, or non-traditional educational entity and requires an EOC Grade Conversion score of 70 or above for the local district to post credit to their transcript.

RACE ASIAN

RACE ASIAN is a code that indicates the race of a student. Valid codes are:

RACE BLACK

RACE BLACK is a code that indicates the race of a student. Valid codes are:

RACE INDIAN

RACE INDIAN is a code that indicates the race of a student. Valid codes are:

RACE PACIFIC is a code that indicates the race of a student. Valid codes are:

RACE WHITE

RACE WHITE is a code that indicates the race of a student. Valid codes are:

Code	Description	Includes
W	White	One of the five race indicators that can be set to yes or no for a student. More than
		one race indicator can apply per student. RACE WHITE must be ' W ' (yes) or ' N ' (no).
N	Non-White	A person having origins in any of the original peoples of Europe, the Middle East, or North Africa.

REPORT PERIOD

REPORT PERIOD indicates the cycle in which the data is collected. There are two report periods in the Pre-ID data collection.

SCHOOL CODE

SCHOOL CODE is 4-digit code that identities the public school in Georgia. The **SCHOOL** must be listed in the Georgia Department of Education's *Facilities Database* as an active PRE-ID reporting school for the PRE-ID **REPORT PERIOD**. Pre-ID data should be submitted for students at all schools.

SECTION 504

SECTION 504 - At the time of this test administration, this student qualified for Section 504.

SRC CODE

SRC CODE (Primary Area) indicates the exceptionality of the student:

SYSTEM CODE

SYSTEM CODE is a number that identifies each school district. See the DOE *Facilities Database* for a list of all the valid system codes. **SYSTEM CODE** is reported in PRE-ID.

TEACHER FIRST NAME

TEACHER FIRST NAME is a code which identifies the teacher's **FIRST NAME**. This field is optional except for the EOC. The teacher's name is required for EOC labels.

TEACHER LAST NAME

TEACHER LAST NAME is a code which identifies the teacher's **LAST NAME**. This field is optional except for the EOC and EOG. The teacher's name is required for EOC and EOG labels.

TEST ID

TEST ID identifies the test administration. This is a two-digit numeric field.

Below is a list of valid grade levels for each of the test IDs.
