# **New Error - DJJ Student Re-enrollment**

Added because:

You send up 'all active' students to GUIDE. That updates any changed identity data. (That's good – especially before a collection like FTE-3 coming up!)

But you don't always know when a student gets 'enrolled' in DJJ.

DJJ has to re-claim students because you did not have a withdrawal date for a student.

E1143 states, Student is currently claimed in DJJ. If you have confirmed this student's reenrollment, this error must be relieved by GUIDE Admin before claiming the student manually online. All students must be confirmed as either re-enrolled or not.

You need to confirm that the student is BACK from DJJ.

Your comment, sent in Portal mail to 'P Miller' (search), must say that you have confirmed this student has re-enrolled. Patty will relieve the error. You will have to manually claim the student.

# The Difference Between Being Eligible for a Free or Reduced Meal vs. Eating Free of Charge

Last school year, 2020-2021, the U.S. School Nutrition Program still asked for students to complete the F/R Meal application, but then provided the money to allow all students to eat free of charge.

This school year, 2021-2022, the U.S. School Nutrition Program extended the Seamless Summer Option to allow all students to eat free of charge. They said that students did not have to complete the F/R Meal application.

# The Difference Between Being Eligible for aFree or Reduced Mealvs.Eating Free of Charge

At schools that do not have a school-wide meal program, the accountability group of Economically Disadvantaged comes from the data element - eligible for a Free or Reduced-price meal.

Do your best to collect those meal applications this year. Verify the percentages reported in November compared to the SR collection.

At a school that does not have a school-wide meal program, DO NOT mark every student in the school eligible for a free meal because they were provided all meals free of charge.



# EIP GUIDANCE Continuing the Commitment to Flexibility

## A New EIP Program Guidance Memo was sent out on February 1 to Superintendents

Reporting EIP teachers' assignment records in CPI (the CPI-C type record):

- All certified personnel must have a Clearance Certificate issued by PSC.
- In addition, EIP teachers may be reported with any of the following ASSIGNMENT CERTIFICATION TYPES:
  - WT
  - BT
  - CHW
  - SRT, etc.

# ASSIGNMENT FIELD CODE: Any held field is acceptable for EIP teachers.

# A New EIP Program Guidance Memo Will Be Coming Out Soon

- EIP teachers must have an assignment record with one of the following ASSIGNMENT JOB CODES:
  - 131 Early Intervention (EIP) Kindergarten Teacher
  - 132 Early Intervention (EIP) Primary Teacher 1-3
  - 133 Early Intervention (EIP) 4th and 5th Grade Teacher

\*All EIP teachers must have an assignment record with an EIP Job Code and percentage of time.

- ELA Reading 2R0, 2R1, 2R2, 2R3, 2R8
- Elementary Instruction 920, 922, 923, 928
- Math 270, 271, 272, 273, 278

# **From the Legislation**

• **Per state law:** Effective July 1, 2021, the EIP program requirements, such as class size are no longer waivable for Strategic Waivers School Systems, Charter Systems, and Charter Schools.



# **EIP Teachers Must Have an EIP Assignment in CPI**

Teachers listed as the only teacher of an EIP class (DM '2' self- contained and DM '4' reduced class size).

**E7031** - EIP DM '2' (Self-contained) or '4' (Reduced Class Size) reported on this class in SC. The teacher (COURSE TEACHER CODE) must have an assignment Job Code = '131', '132', or '133' (EIP job codes) in CPI.

Teachers listed as the additional teacher of an EIP class (DM '1' augmented, '3' pull-out, '5' reading recovery)

**E7032** - EIP DM '1' (Augmented), '3' (Pull-out), '5' (Reading Recovery), or '6' (Innovative) reported on this class in SC, a teacher of this class must have an assignment Job Code = '131', '132', or '133' (EIP job codes) in CPI.



# E7031 and E7032

There is a report in SC, (from the SC Main Menu, go to Student Class Reports, Teacher Reports, <u>SC020 - EIP Class without Teacher with EIP Job Code</u>), that shows the job codes reported for EIP Teachers. In CPI, the same report is on the Main Menu.

# **EIP Reminders**

Instructional models that are no longer in compliance with SB 59 (students coded in Student Class with EIP DM '04', Reduced Class Model) can be funded using CARES I, CARES II, and ARP ESSER (including learning loss) funds (teacher coded in CPI with ASSIGNMENT FUND CODE '03'). CARES/ARP funding do not have "supplement versus supplant" requirements and programs/initiatives funded by CARES/ARP funding are not restricted by class size waivers or other flexibilities afforded by your performance contracts.

- What will be allowed The EIP teacher of an **EIP DM** '04' (Reduced Class Model) class must have a **FUND CODE** = '03' on the assignment with **JOB CODE** = '131', '132', or '133'.
- What won't be allowed The EIP teacher of an **EIP DM** '04' (Reduced Class Model) class, cannot have a **FUND CODE** indicating state funding ('00') or Federal funding (all except '03') on the assignment with **JOB CODE** = '131', '132', or '133'.



# **EIP Reminders**

 E7028 - EIP DM = '4' (Reduced Class Size) in SC. The teacher (COURSE TEACHER CODE) in CPI must have FUND CODE = '03' (paid by CARES I, II, or ARP/ESSER funds, not state T&E funded).

DATA HAS TO BE FIXED in CPI, then revalidate in both SC and CPI.

# **New Error Cross-Checks**

- E1152 Will not allow sign-off in CPI if SC errors
- E1151 Will not allow sign-off in FTE if SC errors

Not really new errors – they are 'stoppers' in FTE and CPI to keep you from signing-off with errors in SC. This should help prevent having to re-open SC/FTE/CPI when there are errors in another data collection.
