#### **ENRICHMENT**

This student is receiving enriched class content and/or service in this class beyond the general education curriculum. Local criteria were used to qualify a student with exceptional ability and motivation who was not identified in the gifted program.

NOTE: The FTE PROGRAM CODE must be a general education code, not Gifted ('I')

# **SC Gifted Delivery Models**

#### Situations where ENRICHMENT is unlikely or not possible:

 Not all of the students who are not getting gifted services in a class with students getting gifted services are getting an enriched curriculum.

#### For example:

- A class of 3<sup>rd</sup> graders with a Gifted-endorsed teacher coming in to provide gifted services using the collaborative model. The Gifted Teacher is not enriching the curriculum of the whole class.
- 2) In a Resource Class, all of the students are getting gifted services.
- 3) With the models Internship/Mentorship, Directed Study and Community Service Learning, gifted service/instruction is individual, there is no group instruction.



# **SC Gifted Delivery Models**

Situations where ENRICHMENT is possible are highlighted below:

Delivery Model	DM Code #	Delivery Model Description (abbreviated)			
Resource Class	1	All students must have been identified as gifted by SBOE criteria. This is an interdisciplinary course taught in a separate classroom.			
Advanced Content (not AP or IB)	2	NOT FOR AP or IB. Students are homogeneously grouped on the basis of achievement and interests. The district may elect to include students who are not identified as gifted, but who demonstrate exceptional ability and motivation in a particular content area.			
Cluster Grouping	3	Identified gifted students are placed as a group into an otherwise heterogeneous classroom.			
Collaborative	4	A maximum of eight identified gifted students are placed as a group into an otherwise heterogeneous classroom. Direct instruction is provided by the students' regular classroom teacher who collaborates with a designated gifted teacher.			
Internship/ Mentorship	5	A gifted student works with a mentor to explore a profession of interest.

Innovative Models	7	The GaDOE encourages the development of innovative programs for gifted students which are clearly in accordance with the needs of the gifted learners and the philosophy of the district.
Advanced Placement (AP)	8	Students are homogeneously grouped on the basis of achievement and interests. The district may elect to include students who are not identified as gifted, but who demonstrate exceptional ability and motivation in a particular content area.
International Baccalaureate (IB)	9	Students are homogeneously grouped on the basis of achievement and interests. The district may elect to include students who are not identified as gifted, but who demonstrate exceptional ability and motivation in a particular content area.
Directed Study	Α	A gifted student works under the direction of a gifted endorsed teacher to explore a challenge/subject of interest.
Community Service Learning	В	A gifted student works under the direction of a gifted endorsed teacher to complete a project with community service learning.

- Q. All of our schools are 100% in-person. Parents were given a choice at the beginning of the school year to sign up for our virtual academy which is 100% virtual. It is a PROGRAM not a SCHOOL so students in the virtual academy are reported back at their home schools. How do we mark the schools? How can we record that the virtual academy is virtual 100% of the time?
- A. Mark the schools in column 1 (100% in-person learning OR, 100% virtual/remote learning based on parent/student choice).

Q. We have had to go to 4 days/week in-person and 1 day/week virtual at all of our 5 schools because of a bus driver shortage. The virtual day is different at each school so the buses only run to 4 schools every day. What type of Instructional Model would that be?

A. Use column 4, (Hybrid A/B: students attend in-person instruction and virtual/remote on alternating days or weeks), to show that the students are rotating between in-person and virtual learning.

- Q. Two of our schools had to go to virtual last week because of high infection rates at their schools. Some of our students were attending a virtual academy by choice and now all of our in-person students will be virtual. How should we mark these students?
- A. Mark the schools in column 3 (100% virtual/remote learning, no in-person learning).



## Questions from 8/31 Related to Instructional **Models**

- the last choice "School operations cancelled" because the governor is closing schools?
- Q. Will Friday (Sept. 3) be an example of A. No, the "School operations cancelled, no instruction occurred" is intended for when a school or district has to shut down for a period of time because too many instructors or students have been affected by Covid to make learning practical.
- Q. Is this to be coded for any change (i.e. closed due to weather) or is it just covid related closes?
- A. The Instructional Model should be updated for a school if there is a change in the Instructional Model. If the Instructional Model changes, this should be reported. If a school closes because of weather or for an unexpected non-school day, like Friday, Sept. 3, you can mark on your school calendar that this is a non-school day but you don't need to change the Instructional Model.

# **Displaced Students**

(FTE) RESIDENT STATUS CODE – '8' Displaced due to a natural disaster.

(FTE & SR) SCHOOL ENTRY CODE – '6' Enrolled due to natural disaster and displacement.

(FTE & SR) WITHDRAWAL CODE - '6' Displaced due to natural disaster

(SR) COUNTY OF RESIDENCE - Is the code for the state from which the student was displaced.

(FTE & SR) SYSTEM OF RESIDENCY / SCHOOL SYSTEM OF RESIDENCE — Is the code for the state from which the student was displaced.

# **Displaced Students**

Q; Are we going to get a code for students who are displaced from Haiti due to the earthquake that occurred on August 14?

A: Check the definition of displaced students (A displaced student is a student who has transferred to your district due to a natural disaster such as a hurricane, fire, or flood. This is not a situation where a student's family plans to move. They are forced to move and may now be homeless. This designation does not include students from a family who were flooded out of their home by a burst pipe, or house fire. The student's home must have been in an area declared a disaster by the governor of the state.) If a student enrolls from Haiti, use the SCHOOL ENTRY CODE 'K' for enrolled from another country.

Q: Will anything be added if we receive students related to the Afghanistan events?

A: If a student enrolls from Afghanistan, use the SCHOOL ENTRY CODE 'K' for enrolled from another country.



## Student Class Q &A

Q. Would a good rule of thumb be to schedule 05.XX speech for any PK student who is enrolled in our school's PK program and do not schedule 05.XX for any student who comes into our school for speech service?

A. For enrolled students, the new 05.xx speech course should only be scheduled if the student is getting a speech service outside of his scheduled class. If the student is a service plan student and only comes in for a service and is not enrolled, then that student would not be sent in SC or SR.



## Student Class Q &A

Q. If we use Reduced Class size and pay for it with federal funds, can class size be waived?	A. Class size can no longer be waived for EIP.
Q. Some of our students have 2 math classes scheduled. For the first hour, all kids are in the class. Then, for the 2nd hour, some special ed kids are pulled out to go to a resource class (as an example). Do we have to post a grade in each class or can we just post one grade in one of the math classes?	
Q. We have classes scheduled on an A/B rotating schedule. FTE is on 'A' day. What do we send in SC?	A. Everything is sent in SC and we do not distinguish between A/B classes and classes students go to M-F.



## FTE Q & A

Q. In light of the delta variant surge and schools/district transitioning to remote, has GaDOE considered an FTE extended deadline?

A. At this time, there will not be an extension in FTE. The deadline is still Tuesday, October 26, 2021.



# **School Calendar Application**

Q. How do we find out who has access to this? Who has access to the School Calendar? Which roles are given access to the Coordinator should I have the school calendar? Do I need to ask my portal security officer for those rights?

A. The following roles have access to the Calendar Application: Organization Roles of Administrator(District), Charter School Administrator(School), and Charter School School Calendar? As FTE/SC/SR Superintendent(School) for the Application Role of District User.

> Organization Role of Portal User(District) for the Application Role of Other District User.

# School Calendar Application / FTE Data Survey

Q. Our district is observing the
Governor's order to close state
office on Sept 3. Do we need to
adjust our number of school days
in the Data Survey?

A. If the number of Days in your School Calendar changes, please change the number of days in the FTE DATA SURVEY.

Q. Can we recognize Sept. 3 as a "snow" day? Would that require opening of Data Survey?

A. Closing State offices does not mean that you recognize this as a Snow Day. Only re-open the FTE DATA SURVEY if the number of school days change in your District.



# CPI Q & A

Can I give someone access to view CPI reports in the Portal without giving them edit rights?	No, it is all or none for district level employee's. CPI do not have a school level because of HR purposes.
Do we code parapro's with a Cares Act code for CPI?	Yes, you can code para's to Cares Act FUND CODE 03.
