**Displaced Students**

**California – 935**

California was added to the list of states that may have displaced students due to a natural disaster.

In reference to the reporting of displaced students because of recent hurricanes or other natural disasters, please follow these instructions for FTE and Student Record reporting:

A displaced student is a student who has transferred to your district due to a natural disaster such as a hurricane, fire, or flood. This is not a situation where a student's family planned to move. They are forced to move and may now be homeless. The student's home must have been in an area declared a disaster by the governor of the state, country, or territory. This designation does not include students from a family who were flooded out of their home by a burst pipe, or house fire.

Data entry guidelines for displaced students:

- The **WITHDRAWAL CODE** for the school the student withdrew from because of the natural disaster is '6' - Displaced due to natural disaster.
- The **SCHOOL ENTRY CODE** for the new school in which the student enrolls is '6' - Enrolled due to natural disaster displacement.
- Only for displaced students, enter prior system of residence in the **SCHOOL SYSTEM OF RESIDENCE** field.
- For displaced students only, enter the prior county or state in the **COUNTY OF RESIDENCE** field.
